(a) Notice of motion:

That it be a recommendation to the National Rifle Association of Australia Limited that the preamble note in Chapter 18 (Match Rifle Target Shooting (MR) of the Standard shooting rules be changed from:

Note: Where there is no rule applicable within this section the Standard Shooting Rules for Target Rifle [TR] will apply.

To now read:

Note:

(1) Where there is no rule applicable within this section the Standard Shooting Rules for Target Rifle [TR] will apply.

(2) Only Match Rifle, F Open & F/TR may additionally be included at State and National Championships, at the discretion of the State promoting each event. Conditions for each of these disciplines must comply fully with the relevant sections of the SSR's.

And to include the following rules:

18.4.4.2

When F Class Open or FTR is shot at State or National Competition an ICFRA 1000 yard super V is to be used and shot position to be marked with a White Spotter.

18.5.4.1

When F Class Open or FTR is shot at State or National Competition, An ICFRA 1000 yard Super V measuring 127mm shall be placed inside the Central Bull. The Super V shot shall be marked as an X onto the competitors score card for use in scoring for F Class Open and FTR.
